Release, Waiver of Liability, Indemnity, and Medical Release

I, (the Participant) am aware that during my participation at the Fire Arts Center—as a studio member or as a member of any class, instruction, or other activity in which I am participating at the Fire Arts Center—I will be exposed to certain risks and hazards. I am aware that these risks and hazards may result in property damage, personal injury, or death. In consideration of being permitted to become a studio member or to enroll in and participate in any class, instruction, or other activity, I agree to the following:

1. I hereby release, waive, discharge, and covenant not to sue Fire Arts, Inc., its directors, officers, employees, including other studio members, and agents (hereinafter, referred to as "Releasees") from all liability to me, my personal representatives, assigns, heirs, and next of kin for any loss or damage in any claim or demands therefore, on account of property damage, personal injury, or death, whether caused by the negligence of the Releasees or otherwise, arising out of the class, instruction, or other activity.
2. I agree to indemnify, save, and hold harmless the Releasees and each of them from any loss, liability, damage, or cost that they may incur due to my enrollment or participation in the class, instruction, or other activity, whether caused by the negligence of the Releasees or otherwise.
3. I hereby assume full responsibility and risk of bodily injury, death, or property damage due to the negligence of Releasees or otherwise arising out of the class, instruction, or other activity. I understand that there are certain risks and dangers that may occur, including but not limited to: the hazards of working with glass and clay, cutting tools, firing equipment, and machinery; exposure to personal injury; accident or illness.
4. I further expressly agree that the foregoing Release, Waiver of Liability, and Indemnity Agreement is intended to be as broad and as inclusive as is permitted by the laws of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall continue in full legal force and effect.
5. I agree to indemnify, save, and hold harmless the Releasees and each of them from any loss, liability, damage, or cost that they may incur as a result of my dog being on the premises.
6. I have read and voluntarily signed the Release, Waiver of Liability, and Indemnity Agreement and further agree that no oral representation, statement, or inducements not contained in this document have been made.
7. **I agree that while participating in this activity, I will conform to all policies of Fire Arts**—copies of which are posted and/or available in the studio—and abide by all state and federal laws. I also agree to accept and follow the directions of the activity leader(s) or instructor(s) and to act in a mature and responsible manner. I further agree to follow all safety procedures including the use of appropriate protective gear. If I am an instructor or a member of Fire Arts, Inc., I agree that I am responsible for having all of my guests or students, as the case may be, properly trained and instructed to use the equipment and will be solely responsible for their adherence to safety procedures.
8. I hereby grant permission for the performance of any emergency medical treatment that may be required in the case of an accident wherein I am rendered unconscious or unable to approve of the required medical treatment. In the event that I become the victim of an accident, I will hold harmless from any liability or negligent actions that may arise in connection with the stabilization, evacuation, transportation, and emergency care I receive while secondary aid resources are being sought.
9. I hereby agree to permit Fire Arts employees, agents, and other guests to take photographs and make film records of the class, instruction, or other activity without further recourse. I understand and agree that such photographs and/or film records may be used for commercial and/or promotional purposes.
10. This agreement is valid as long as the Participant is a studio member, enrolled in and/or participating in any class, instruction, or other activity at The Fire Arts Center.
11. I agree to observe all COVID 19 instructions as provided with this document or as otherwise posted or communicated.
